

**Sliding Fee Schedule effective
March 1, 2024**

The sliding fee schedule is used to determine the amount you will pay for services at Options for Southern Oregon, Inc. Fees are based on family size and annual income. A family's income is the money coming into the house in which they reside. Dependents are all individuals that rely on that income for support. **If you fall into the A, B, C or D category, you may be eligible for the Oregon Health Plan. Please ask for details.** Instructions for determining fee category are shown below.

Determine the gross household income (food stamps are not included as income):

- Weekly – weekly gross amount, multiply by 52
- Biweekly – bi-weekly gross amount, multiply by 26
- Monthly- monthly gross amount, multiple by 12

1. Determine the number of individuals dependent on the income.
Example: Client, plus spouse, plus 1 child = 3 dependents.
2. Locate the column on the annual scale showing the correct number in household.
3. Go across the row until you find the income range that includes your gross household income.
Example: annual household income of \$30,000 with 3 dependents falls within the range of \$25,821-\$32,275.
4. Find the applicable fee by looking in the top row. For this example the fee for each service is \$15, which means you will pay this amount for each service you receive.

Note that this fee amount is due at the time services are provided. If you receive services outside of Options, (school, community, etc.), you will be billed for this amount.
